The Cape Cod Human Resources Association is currently seeking proposals from speakers to present at monthly membership meetings. Cape Cod Human Resources Association strives to provide relevant, informative human resources topics to our membership from experienced, reputable speakers.

About CCHRA:

The Association is comprised of Human Resource Professionals representing industries from the Cape & Islands in the areas of education, finance, government, health care, hospitality, manufacturing, and professional services. Membership shares the common goal of advancing the profession of human resource management.

Monthly membership meetings are held September through June and feature a guest speaker whose topic is of HR management interest. The interests are diverse in nature and in the past topics presented touched upon the areas of affirmative action, leadership, employee assistance, training, legal issues, compensation/benefits, compliance, workforce demographics, recruitment/selection, and health care. All Proposals must include the following criteria:

- Biographical information on the speaker(s). If associated with a business, please include business information as well.
- Detailed description of the topic to be considered for presentation (maximum of two pages) Articulate learning goals for participants*
- Contact information, including email address, and telephone for each speaker
- A link to a sample video of speaking at another event or a recorded sample

CCHRA's focus is on educating our membership; we ask that speakers respect our focus by not showcasing or promoting the speaker's practice, services, or products.

Deadline:

ALL PROPOSALS MUST BE RECEIVED BY AUGUST 1, 2022.

Proposals will be considered on a rolling basis with preference being given by submittal date. The Program Committee will review all completed proposals which meet the criteria outlined above and make the final selections from those that have passed the program committee's review.

Submission Best Practices

We invite you to submit a thought-provoking, informative session to join the ranks of seasoned speakers who are passionate about sharing their expertise and primary research in HR, leadership, and building a human-centered workplace. We search year-round for humans who are willing to partner with CCHRA to deliver the best possible content experience and relevance for our audience. To put it simply, CCHRA speakers should be bold, visionary, and authentic.

What you need to know:

- 1. A high-quality speaking proposal must be submitted by the submission deadline. **Don't wait** until the deadline to submit. Avoid the rush and stand out from the crowd!
- 2. A link to a video sample is required as part of the proposal. If you don't have a video of a past speaking engagement, please record one for your application.
- 3. Accepted speakers must be available to attend the entire in-person or virtual event.
- 4. Due to the large number of submissions and limited slots, even submissions that meet all criteria may not be selected. However, welcome everyone into the wider CCHRA community!

If you're selected as a speaker, here's what you'll experience:

- 1. The opportunity for you to build and nurture your network with the CCHRA community and be first-in-line for additional partnership opportunities with CCHRA.
- 2. CCHRA will cover your registration and hotel accommodations for one-night for in-person events
